

## **Rescuestuff Firearm transfer, sales and storage policy**

- Rescuestuff does NOT provide services for private firearm sales. Every firearm transferred to Rescuestuff is subject to a transfer fee: Rifles \$30, Pistols \$40
- A transferred firearm MUST meet all requirements of New York State and Federal law and must be shipped with the following:
  - An operational gun lock that works for that firearm. You may also purchase one at Rescuestuff prior to taking possession of the firearm.
  - Appropriate gun case for the firearm(s)
  - A copy of the transferor's FFL (They can contact Rescuestuff at [transfers@rescuestuff.net](mailto:transfers@rescuestuff.net) to get a copy of our FFL).
  - If shipped from a private person they must send us a copy of their drivers license.
- Any firearm that does not meet NYS or federal law requirements will be returned to FFL at the customer's cost. (\$30 + shipping)
- Firearms must be shipped using a reputable carrier which provides tracking information.
- It is the customer's responsibility to make ALL arrangements with the transferring FFL, including delivery of required documents and payment of shipping costs. This includes notifying Rescuestuff of any firearm transfer prior to arrival at our location. Notification is to be made by email only with transferee name in the subject line. Email is [transfers@rescuestuff.net](mailto:transfers@rescuestuff.net). Email must include the following:
  - The make/model of the firearm being shipped to us for transfer
  - All buyers contact information (Name, Address, daytime phone number)
  - Contact information (FFL name, address, daytime phone number, email) for the transferring FFL with contact name
- Please do not call to check on the status of your firearm; use the tracking information provided by your shipping company. You may pick up your firearm 24 hours after it arrives at Rescuestuff. All questions are to be emailed to [transfers@rescuestuff.net](mailto:transfers@rescuestuff.net).
- Firearms transferred to RESCUESTUFF by another FFL, Private Person or Police Department
  - Transferred firearms must be picked-up from Rescuestuff within 7 days after the arrival on our premises.
  - Firearms transferred as part of an Estate or Police turn in will have 30 days to pickup or transfer the firearm.
  - Any firearms not picked up within that grace period will incur a \$5 per day fee
  - Firearms not claimed within 90 days of arrival will be considered abandoned.
- Handguns stored while awaiting permit or amendment
  - Handguns not picked-up within 7 days of receiving the amended license or new permit are subject to a \$5 per day storage fee
  - Handguns not claimed within 90 days of receiving the amended license will be considered abandoned.
- Abandoned firearms: Once a firearm is considered abandoned, Rescuestuff reserves the right to possess and sell the firearm at no further recompense to the customer.
